## **1 Personal Information & Data Collection**

and/or enable us to determine your credit standing and the amount and conditions of the credit facility to be extended to you by Goodnite Eazy in any credit sale transaction including any past, present and future credit sale agreement(s) entered into or to be entered into with you;  
to obtain and/or disclose any Credit Information (as defined in the CRA Act 2010) from and/or to Credit Reporting Agencies or any source deemed appropriate to verify your credit history in relation to your transaction with us. This consent shall remain applicable as long as you are maintaining any transaction with us.

## **3 What are the effects arising from failure to provide Personal Data?**

Please understand that should you provide insufficient information, inaccurate information or decline to provide obligatory information that we request for, we may not be able to process your requirements and/or requests and ultimately be unable to provide you with your requirements and/or requests.

## **4 Disclosure**

Personal Data provided to us will generally be kept confidential but you hereby consent and authorize us to provide or disclose your Personal Data to the following categories of parties:- any person to whom we are compelled or required to do so under law or in response to a competent or government agency;  
any related companies and subsidiaries of the Goodnite Eazy, within and outside Malaysia, including those established in the future;  
our business partners and online affiliates that provide related services or products in connection with our business;  
government agencies, statutory authorities and industry regulators;  
our insurers, auditors, consultants, accountants, lawyers or other financial or professional advisers;  
our sub-contractors or third party service or product providers as may determine to be necessary or appropriate;  
and any credit bureau(s) which we subscribe to.

We shall keep and process your data in a secure manner. We endeavour, where practicable, to implement the appropriate administrative and security safeguards and procedures in accordance with the applicable laws and regulations to prevent the unauthorized or unlawful processing of your Personal Data and the accidental loss or destruction of, or damage to, your Personal Data.
